



- 4. PORT OF DESTINATION : LEIXOES

Report Findings

- 1. Client required 4500 pieces but Supplier provided 4500 pieces.
- 2. Length of material conformed to clients requirements.
- 3. Thickness of material measured 3.8-3.9mm and not the 4.0mm requested by client.
- 4. No plastic bags were used in packing.
- 5. 18 wooden pallets are used for packing the product, wrapped in wood cartons and held together with steel straps.
